## 1 ANNOUNCEMENT / INVITATION

The Icelandic Skating Association in, cooperation with Reykjavik Skating Club, would like to invite you to participate in the Reykjavik International Games 2024 (RIG). Reykjavík International Games is a multisport event which is hosted by Reykjavík city over a two-week period. Further information about the multisport events can be found at <a href="https://www.rig.is">www.rig.is</a>

This will be the 17<sup>th</sup> year figure skating is part of the Reykjavík International Games. With great pleasure we welcome figure skaters from figure skating clubs and ISU Member Federations to participate in this interclub figure skating competition for young and upcoming skaters. The competition will take place immediately preceding our ISU competition for Senior, Junior and Advanced Novice.

## 2 GENERAL REGULATIONS

**Reykjavík International Games 2024** will be conducted in accordance with the ISU Constitution and General Regulations 20121 the Special Regulations & Technical Rules Single & Pair Skating 2022, and the relevant ISU Communications.

Participation in the **Reykjavík International Games 2024** is open to all Competitors who belong to an ISU Member, and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3 b) and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 2526 or any update of this Communication.

In accordance with Rule 109 of the ISU General Regulations and ISU Communication 2526 all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate. Passports of all Skaters, as well as the ISU Clearance Certificate, if applicable, must be presented at the accreditation of the event for verification.

Entries can be done by respective **ISU Member Federations or by clubs.** 

## 3 TECHNICAL DATA

#### PLACE

Main arena (MR): Laugardalur Ice Arena, Múlavegi 1, Reykjavík (an indoor ice-rink with the ice surface of 30 x 60 m, air-conditioned and heated)

Practice arena (PR): same as main arena.

Some practices may be in **Egilshöll Ice Arena**, Fossaleyni 1, Reykjavík (an indoor ice-rink with the ice surface of 30 x 60 m, air-conditioned and heated)

#### 3.1 Competing Categories

Competition rules for all categories will be according to the Icelandic Skating Association's National Competition Rules (see here).

Competition categories are the following:

Cubs Unisex	Not older than 10 on July 1st 2023	FS
Intermediate Women/Men	Not younger than 15 on July 1st 2023	FS
Basic Novice	Has not reached the age of 13 on July 1st 2023	FS
Intermediate Novice	Has not reached the age of 15 on July 1st 2023	FS





## 3 ENTRIES

#### 4.1 Entries by Name

The entries by name must reach the Organizer by <u>Friday, December 22<sup>nd</sup> 2023</u> at 20:00 Local time (GMT) and must be made using the official entry form, **RIG02**, the for RIG Interclub competition.

Confirmation of the skaters accepted to the competition will be published on the website no later than **January** 5<sup>th</sup> 2024.

#### 4.2 Entry fee

The entry fee for skaters is **80** € per participant.

The entry fee must be paid by **Friday**, **December 22**<sup>nd</sup> **2023** to the following bank account – we kindly ask members to make one payment transaction for all their skaters and mark it with the text "RIG2024".

In case a skater has been entered in the competition, but cannot participate, she/he can be replaced by another skater in the same category by another skater from the same member until **January 11**<sup>th</sup> **2024.** Participating members are asked to immediately inform of any changes in their entries by email to <a href="rig@iceskate.is">rig@iceskate.is</a>.

Entry fees are not refunded in case of withdrawal after **Friday, December 22**<sup>nd</sup> **2023.** Entry fee will be refunded if the skater is not accepted (if there will be a limitation of the numbers of entries).

#### 4.3 Entries of Team Members

Official entries of Team Leaders, Team Officials, Team Medical Staff and Coaches and the partner of a Judge will be accepted. Accreditation will be provided to those who are officially accepted by the Organizer.

Only one Coach per Skater will be accredited. An Assistant Team Leader will be accepted for Teams having six(6) and more skaters. Only one Team Official of each Member, including the Member President. Not more than one(1) Team Doctor and one(1) Team Physiotherapist will be accepted as Team Medical Staff, for which the organizer requests the right to have a medical certification (document) presented before accreditation.

The names of all team members must be submitted to the Organizer by <u>Friday, December 22<sup>nd</sup> 2023</u> at 20:00 **Local time (GMT)** and must be made using the official delegation form, **RIG01**, the for RIG Interclub competition.

#### 4.4 General Data Protection Regulation (GDPR)<sup>1</sup>

By entering to this event each competitor, or if a competitor is under the age of 18 their guardian, accepts the following:

- 1. Name of the skater can be published in the list for competitors as well as starting order.
- 2. Results and protocols can be published online on the event website.
- 3. Photographs and video recordings can be made of the skater during RIG 2024

- 4. Footage of the skater can be published on the event website as well as the Host Federations (ÍSS) website.
- 5. Footage of the skater can be published on social media platforms owned by ÍSS (Host Federation)
- 6. Footage of the skater can be used for promotional purposes.
- 7. A third party, on behalf of ÍSS (Host Federation), can take pictures and video recordings of the skater.
- 8. Footage of the skater can be published in the media

#### Conditions for publication of the list of competitors and results, photographs and video recordings

- 1. The Icelandic Skating Association (ISS) is responsible for following Regulation (EU) 2016/679 of the European Parliament.
- 2. We will not use footage of skaters, for promotional purposes, after they retire from their athletic careers. The footage will be preserved with ISS for historical reference.
- 3. Personnel is not allowed to use footage for their personal use.
- 4. Results will be kept published online until the start of the next RIG event. They will be preserved with ISS for historical reference.
- 5. You can at any time revoke an approval already granted. Withdrawal of the consent does not affect the legality of the footage already in place up to that time.

## 5 MEALS, LODGING and TRAVEL EXPENSES

The organizer will not cover the expenses of the teams. Travel expenses, meals and accommodation will be covered by the participants.

## 8 MUSIC / PLANNED PROGRAM CONTENT

The organizer asks to receive all competition music in MP3 format via <a href="this link">this link</a> no later than <a href="January 11th">January 11th</a> 2024 at 20:00 Local Time (GMT). Any other format is not acceptable. Please name the .mp3 file with each competitor's country, name and program (short/free).

Ex: ISL\_John Smith\_Freeskate.mp3

All competitors shall furnish extra copy of competition music of excellent quality on any electronic means to have available at the rink during their event (playback from phones is not accepted), in accordance with ISU Rule 343, paragraph 2. Each program (short/free) must be recorded on a separate track. Please note CDs will not be accepted by the Organizing Committee.

A list of titles, composers and orchestras of the music to be used for the Free Skating Program, in detail, must be submitted to the Organizer using the official music information form, **RIG04**, for the RIG Interclub competition.

If music information is not complete and/or the music is not provided, accreditation will not be granted.

The Program Component Sheet must also be submitted to the Organizer not later than using the official music information form, **RIG03**, for the RIG Interclub competition. The Program Component Sheet must be filled in precisely by each skater in English using the Terminology for the elements listed in the respective ISU Communication.

Forms shall be sent to rig@iceskate.is no later than January 11th 2024 at 20:00 Local Time (GMT).





## 9 ARRIVAL OF PARTICIPANTS / TEAMS

The international airport. Keflavik Airport (KEF), is located with a distance of 40 km from the capital. Travel from the airport to Reykjavík with Fly-bus takes approx. 50 min.

The competitors, coaches, team leaders and additional team officials are responsible for their own arrangements concerning ground transportation to and from the airport.

## 11 ACCREDITATION

The Accreditation is planned at the ice rink / Laugardalur Ice Arena upon arrival. Opening times of the accreditation will be published online.

Accreditation as a Team Member will be given to all entered Judges, Competitors and one Team Leader per participating team, one Coach per competitor, two medical persons and one Team Official of ISU Members. Accreditation will only be granted to persons in those various functions if officially entered and named through their ISU Member. Chaperons will not receive accreditation.

## 12 OPENING DRAW

Opening draw will take place on Thursday, January 25<sup>th</sup> 2024. Starting order will be made public on the official website immediately.

## 13 PRESENTATION OF MEDALS

In categories Chicks and Cubs, the total score will not be announced at competition. Furthermore, the best placed competitors will not be announced but every competitor will receive a participation diploma. These categories are Unisex.

In categories; Intermediate Women/Men, Basic Novice and Intermediate Novice the three best placed Competitors will be announced and honored. Gold, silver and bronze medals will be presented to the medalists.

## 14 PROTOCOL / LIST OF RESULTS

The marking system (ISU Judging System) as described in ISU Technical Rule Single & Pair Skating 2021. Rule 352 and Rule 353 (Determination and publication of results) will be used.
