The Icelandic Skating Association together with Fjölnir Skating Club would like to invite you to participate in the Northern Lights Trophy 2025.

1 GENERAL REGULATIONS

Northern Lights Trophy 2025 will be conducted in accordance with the ISU Constitution and General Regulations 2024 the Special Regulations & Technical Rules Single & Pair Skating 2024, and the relevant ISU Communications.

Participation in the **Northern Lights Trophy 2025** is open to all Competitors who belong to an ISU Member, and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3 b) and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 2526 or any update of this Communication.

In accordance with Rule 109 of the ISU General Regulations and ISU Communication 2526 all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate. **Passports of all Skaters, as well as the ISU Clearance Certificate, if applicable, must be presented at the accreditation of the event for verification.**

Entries can be done by respective ISU Member Federations or by clubs.

Please note that Northern Lights Trophy International, will take place at the same time. Details are stated in a separate announcement.

2 TECHNICAL DATA

PLACE **Main arena (MR): Egilshöll Sports Center**, Fossaleynir 1, Reykjavík
(an indoor ice-rink with the ice surface of 30 x 60 m, air-conditioned and heated)

Practice arena (PR): same as main arena.
Some practices may take place in **Laugardalur Ice Arena**, Múlavegur 1, Reykjavík
(an indoor ice-rink with the ice surface of 30 x 60 m, air-conditioned and heated)

Competition rules for Basic Novice and Intermediate Novice will be in accordance with ISU Communication No. 2699 or any subsequent updates. Intermediate W/M will be according to the Icelandic Skating Association's National Competition Rules ([see here](#)).

3 ENTRIES

ENTRIES BY NAME

The entries by name must reach the Organizer by **Tuesday, September 30th 2025 at 20:00 Local time (GMT)** and must be made using the official entry form, NLT02.

ENTRY FEE

The entry fee for all categories in the interclub competition is **85 €** per participant.

Entry fees are not refunded in case of withdrawal after **Tuesday, September 30th 2025**. Entry fee will be refunded if the skater is not accepted (if there will be a limitation of the numbers of entries).

ENTRIES OF TEAM MEMBERS

Official entries of Team Leaders, Team Officials, Team Medical Staff and Coaches and the partner of a Judge will be accepted. Accreditation will be provided to those who are officially accepted by the Organizer.

Only one Coach per Skater will be accredited. An Assistant Team Leader will be accepted for Teams having six(6) and more skaters. Only one Team Official of each Member, including the Member President. Not more than one(1) Team Doctor and one(1) Team Physiotherapist will be accepted as Team Medical Staff, for which the organizer requests the right to have a medical certification (document) presented before accreditation.

The entries by name must reach the Organizer by **Tuesday, September 30th 2025 at 20:00 Local time (GMT)** and must be made using the official entry form, NLT01.

GENERAL DATA PROTECTION REGULATION (GDPR)¹

By entering to this event each competitor, or if a competitor is under the age of 18 their guardian, accepts the following:

1. Name of the skater can be published in the list for competitors as well as starting order.
2. Results and protocols can be published online on the event website.
3. Photographs and video recordings can be made of the skater during Northern Light Trophy 2024
4. Footage of the skater can be published on the event website as well as the Host Federations (ÍSS) website.
5. Footage of the skater can be published on social media platforms owned by ÍSS (Host Federation)
6. Footage of the skater can be used for promotional purposes.
7. A third party, on behalf of ÍSS (Host Federation), can take pictures and video recordings of the skater.
8. Footage of the skater can be published in the media

Conditions for publication of the list of competitors and results, photographs and video recordings

1. The Icelandic Skating Association (ISS) is responsible for following Regulation (EU) 2016/679 of the European Parliament.
2. We will not use footage of skaters, for promotional purposes, after they retire from their athletic careers. The footage will be preserved with ISS for historical reference.
3. Personnel is not allowed to use footage for their personal use.
4. Results will be kept published online until the start of the next Northern Lights Trophy. They will be preserved with ISS for historical reference.
5. You can at any time revoke an approval already granted. Withdrawal of the consent does not affect the legality of the footage already in place up to that time.

4 MEALS, LODGING and TRAVEL EXPENSES

The organizer will not cover the expenses of the teams. Travel expenses, meals and accommodation will be covered by the participants.

5 PRACTICE

Unofficial practice will be offered, time permitting, after the entry deadline has passed. Information will be published on the event website.

6 MUSIC / PLANNED PROGRAM CONTENT

The organizer asks to receive all competition music in MP3 format via [this link](#) no later than **October 16th 2025 at 20:00 Local Time (GMT)**. Any other format is not acceptable. Please name the .mp3 file with each competitor's category, country, name and program (short/free).

Ex: *SEN_ISL_John Smith_Freeskate.mp3*

All competitors shall furnish extra copy of competition music of excellent quality on any electronic means to have available at the rink during their event (playback from phones is not accepted), in accordance with ISU Rule 343, paragraph 2. Each program (short/free) must be recorded on a separate track. Please note CDs will not be accepted by the Organizing Committee.

A list of titles, composers and orchestras of the music to be used for the Short Program and Free Skating Program must be entered, in detail, by the ISU Member of the Skater(s) on the dedicated ISU platform.

If music information is not complete and/or the music is not provided, accreditation will not be granted.

The Program Component Sheet must also be entered by the ISU Member to the Skater(s) on the dedicated ISU platform. The Program Content Sheet must be filled in precisely by each skater in English using the Terminology for the elements listed in the respective ISU Communication.

7 ARRIVAL OF PARTICIPANTS / TEAMS

The international airport, Keflavik Airport (KEF), is located within a distance of 40 km from the capital. Travel from the airport to Reykjavík with Fly-bus takes approx. 50 min.

The competitors, coaches, team leaders and additional team officials are responsible for their own arrangements concerning ground transportation to and from the airport.

Buses are available from Keflavik airport and stop at all main hotels. Further information about the bus service can be found at www.isavia.is/en/keflavik-airport/parking-and-transport and www.re.is/tour/flybus/.

All competitors, coaches and team leaders are asked to take care of their accommodation and bear their own expenses.

9 ACCREDITATION

The Accreditation is planned at the **ice rink / Egilshöll Sports Center**. Opening times of the accreditation will be published online.

Accreditation as a Team Member will be given to all entered Judges, Competitors and one Team Leader per participating team, one Coach per competitor, two medical persons and one Team Official of ISU Members. Accreditation will only be granted to persons in those various functions if officially entered and named through their ISU Member. Chaperons will not receive accreditation.

10 OPENING DRAW

Opening draw will take place **online** on Wednesday, October 29th 2025.
Starting order will be made public on the official website immediately.

11 PRESENTATION OF MEDALS

The three best placed Competitors in each event will be announced and honored. Gold, silver and bronze medals will be presented to the medalists.

12 PROTOCOL / LIST OF RESULTS

The marking system (ISU Judging System) as described in ISU Technical Rule Single & Pair Skating 2024. Rule 352 and Rule 353 (Determination and publication of results) will be used.

13 INSURANCE / LIABILITY

In accordance with Rule 119, it is the sole obligation of each Member participating to provide medical and accident insurance for their athletes, officials and all other members of the Member's team. Such insurance must assure full medical attendance and also the return of the ill or injured person to the home country by air transport or by other expeditions.

14 INITIAL JUDGES MEETING/ROUND TABLE DISCUSSION

The initial Judges meeting and the Technical panel meeting will be held at the ice rink **Thursday, October 30th 2025**. The exact times will be announced after the practice schedule has been completed. Round Table Discussions will be held on Sunday (see schedule).
